3. We believe in the death of our Lord Jesus Christ, his Virgin birth, his sinless life, his miracles, his atoning death on the cross, his burial and his resurrection from the dead. We believe he is seated at the right hand of the Father. We believe in the rapture. We believe in his second coming.
4. We believe that all of humanity is lost. Their only salvation is accepting Jesus Christ as Lord. We believe that occurs when you ask Jesus to forgive you of your sins, believe that he was raised from the dead, and strive to follow him.
5. We believe the Holy Spirit indwells all believers at the point of salvation.
6. We believe baptism by immersion is following the example of Jesus Christ. While not essential for salvation, it is an act of obedience and demonstration of faith. We do not baptize infants.
7. We believe baptism and communion are the two ordinances of the church.
